## LAWYER REFERRAL SERVICE

The Lawyer Referral Service is Sponsored by the El Paso Bar Association and is located at:

530 U.S. Courthouse

Its purpose is to aid those El Pasoans who are not acquainted with a lawyer to find one who specializes in the type of problem which the client has. The client pays \$20.00 and is referred to a lawyer who is a member of the Lawyer Referral Panel.

The Referral Service is a voluntary group, comprised of 66 lawyers who filled out a form stating in which categories they wished their names placed. Any paid member of the El Paso Bar Association is eligible to have his or her name listed with this Service.

Clients come from Fort Bliss, are newcomers to the area, and are those who have no idea whom to call for legal help. These people are referred to the Lawyer Referral office by the Red Cross, the Legal Aid Society, Judge Advocate General's office or any of many service agencies within the city. But primarily they call because of the ad in the yellow pages of the telephone book. An average of 30 phone calls per day are received, with approximately 60 to 70 people per month being referred to an attorney.

In a very real effort to be of community service, the El Paso Bar Association sponsors and funds the Lawyer Referral Service. It does not pay its own way. Any interested attorney who wishes to have his or her name listed on the Referral Panel may call 532-7052.

## PRO BONO PROJECT

The Pro Bono Project is sponsored by the El Paso County Bar Association. It has been serving El Paso County since 1982. It is the first mandatory pro bono program operating under a District Court Order in which every attorney licensed to practice law in El Paso County is obligated to accept two pro bono domestic relations cases per year. Initial screening, referral and follow-up is done by the staff of the Pro Bono Project. The purpose is to assist low-income El Pasoans.

The office staff consists of a full-time project coordinator, a full-time secretary/receptionist, and a full-time secretary/paralegal. The program is currently administered by the El Paso Legal Assistance Society.

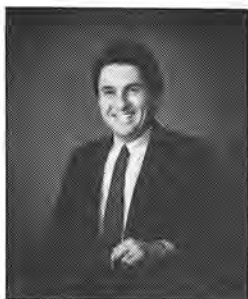
The office is located at 1220 N. Stanton, El Paso, Texas 79902. Persons wishing to be interviewed by the Project should call 544-5276 for an appointment.
