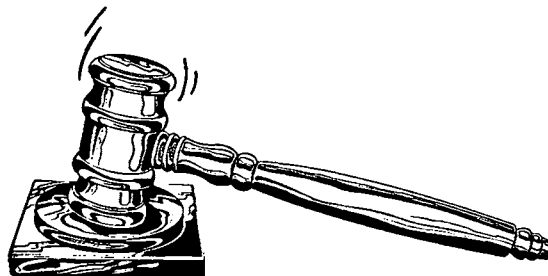

Lawyer Referral Service

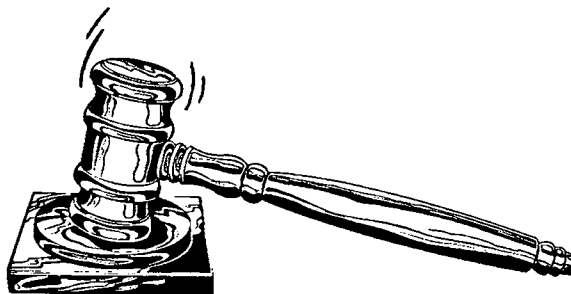
The Lawyer Referral Service is Sponsored by the El Paso Bar Association and is located at:

El Paso County Courthouse
500 E. San Antonio, Room L115
El Paso, TX 79901

Its purpose is to aid those El Pasoans who are not acquainted with a lawyer to find one who specializes in the type of problem which the client has. The client pays \$20.00 and is referred to a lawyer who is a member of the Lawyer Referral Panel.

Clients come from Fort Bliss, are newcomers to the area, and are those who have no idea whom to call for legal help. These people are referred to the Lawyer Referral office by the Red Cross, the Legal Aid Society, Judge Advocate General's office or any of many service agencies within the city. Primarily they call because of the ad in the yellow pages of the telephone book. An average of 50 phone calls per day are received, with approximately 150 - 200 people per month being referred to an attorney.

In a very real effort to be of community service, the El Paso Bar Association sponsors and funds the Lawyer Referral Service. It does not pay its own way. Any interested attorney who wishes to have his or her name listed on the Referral Panel may call 532 - 7052.
