Too often we let slide testimony that is not reliable because we are not as aggressive as we should be on "Intoxilizers" and "Radar" because we don't know how they work. Well neither does anyone else most of the time, so, we need to attack conjecture and make sure scientific evidence is SCIENTIFIC and not just what the officer wants the judge/jury to believe. ADMINISTRATIVE DECISION

On July 17, 2008, this cause was convened for a license revocation hearing. The Defendant whose Texas driver's license number is 80416088 appeared through his attorney of record and announced ready. The Department appeared through its attorney and announced ready. Having heard and considered the evidence presented, the Administrative Law Judge finds that the State Office of Administrative Hearings has jurisdiction over this cause, and further makes the following findings based on a preponderance of the evidence standard:

FINDINGS OF FACT

The undersigned Judge is well aware that the Department is not attempting to prove up a speeding case, but the Kelly predicate must be established in a case in which speed is referenced AND the defendant objects to the speed.¹ The Officer's Sworn Report² states "that the driver was going 71.mph in a 60 mph zone." But, the officer testified that the radar has never been calibrated in four years. Although the underlying scientific principles of radar are undisputable and valid as a matter of law, there is an issue of reliability when the radar has not been calibrated.


Although the officer testified, there is no testimony regarding the officer's opinion regarding the speed of the vehicle, which would have provided reasonable suspicion.

Therefore, the Department has not met its burden of proof.

CONCLUSIONS OF LAW

Based on the foregoing, the Judge concludes the evidence presented in this case was insufficient to establish all the elements set out in Tcx. Transp. Code Ann. § 724.042 by a preponderance of the evidence.



Common Clashes: Politics, Pressure and the Public Defender's Office

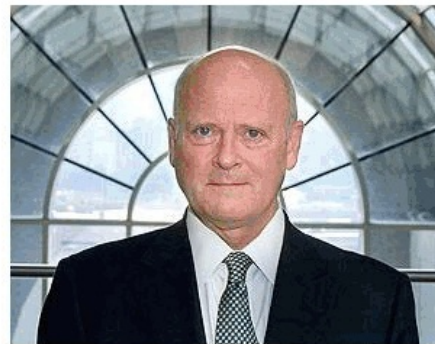
On June 10, the Task Force on Indigent Defense was preparing to release a second edition of its "Blueprint for Creating a Public Defender Office in Texas" when it thought better of that idea.

The reason? That very day Brad Lollar, chief of the Dallas County Public Defender's Office — the largest and oldest one in Texas — had turned in his resignation to the Dallas County Commissioners Court amidst controversy.

The blueprint "was ready to go, but we thought we better wait a week," says Wesley Shackelford, special counsel for the task force. "I mean, we didn't want those two stories coming out the same day."

The task force eventually released the blueprint eight days later. It outlines how counties can meet the requirements of the Fair Defense Act of 2001 — a Texas law that requires timely appointment of counsel to indigent defendants — and save money at the same time by setting up public defenders' offices.

Shackelford says he considers the Dallas PD's office a "model" for other counties. The blueprint cites the Dallas PD's office for providing "zealous legal defense to individuals who cannot afford representation" — goals that are accomplished through "hiring and training competent attorneys and providing meaningful investigation of cases."



TITLE 3. PUNISHMENTS

CHAPTER 12. PUNISHMENTS

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 12.01. PUNISHMENT IN ACCORDANCE WITH CODE. (a) A person adjudged guilty of an offense under this code shall be punished in accordance with this chapter and the Code of Criminal Procedure.

(b) Penal laws enacted after the effective date of this code shall be classified for punishment purposes in accordance with this chapter.

(c) This chapter does not deprive a court of authority conferred by law to forfeit property, dissolve a corporation, suspend or cancel a license or permit, remove a person from office, cite for contempt, or impose any other civil penalty. The civil penalty may be included in the sentence.

Scientific evidence. LIDAR

Reliability of novel scientific evidence measuring speed of car not established. Prior to D's DWI trial, D filed a pretrial suppression motion alleging that the stop of his vehicle was made without probable cause or reasonable suspicion because the arresting officer, X, failed to prove the reliability of the LIDAR device which the officer used to determine D was speeding. X testified that the LIDAR device indicated D was traveling seventy-six miles per hour in an area where the posted speed limit was sixty-five. X testified that he is not certified to use LIDAR equipment. When X went on duty on the night in question, he turned the LIDAR device on and it went "through a self-test process" which indicated that it was functioning properly. X testified that he was not sure whether there is a department employee or contractor who maintains the LIDAR equipment and ensures its accuracy and reliability. Held: Reversed. Scientific evidence must be helpful to the trier of fact to be admissible under Texas Rule of Evidence 702, which, among other things, requires that the evidence be reliable. To be reliable, scientific evidence must satisfy three criteria: "1) the underlying scientific theory must be valid; 2) the technique applying the theory must be valid; and 3) the technique must have been applied properly on the occasion in question" [Kelly, 824 SW2d 568, 573]. The proponent of scientific evidence bears the burden of proving its reliability by clear and convincing evidence. It is important to differentiate between novel scientific evidence and "established" scientific evidence, the reliability of which is generally accepted in the relevant scientific community and in a sufficient number of courts [Hernandez, 116 SW3d at 28-29]. In its appellate brief, the State cited several Texas cases affirming the reliability of RADAR technology and several decisions from other states affirming the reliability of LIDAR technology. RADAR and LIDAR are not the same. Radar uses radio waves to measure speed by calculating the frequency variations or "Doppler shift" of the wave reflecting off a moving vehicle. Light Detection and Ranging (LIDAR) is similar to radar, except that it uses an infra red light (a laser beam) in lieu of radio waves to measure the speed of a moving object. Therefore, judicial decisions affirming the reliability of RADAR technology were irrelevant to the question of the reliability of LIDAR. The parties did not cite and the research of the Court of Appeals did not disclose any Texas authorities confirming the reliability or admissibility of LIDAR technology. Therefore, LIDAR technology is novel scientific evidence which may be admissible only after its reliability has been judicially

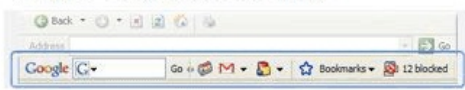


